## Mauser Rebuild Update

A while back I reported on the rebuild of a pair of 1896 Mauser actions.

My workbench project is coming along nicely with the "budget rifle" in condition to shoot, though I don't yet have a scope. I'm thinking of going with something from Alpen optics, since even their budget line of scopes gets rave reviews in the great value category.

To bring you all up to speed, I acquired two old Chilean Mausers that had been chambered to .308. Fearing the actions would explode in my face, and wanting to try my hand at some basement gunsmithing, I opted to rebarrel both. One is now 8x57 and the other is 7.62x39. The 8x57 is the "budget gun" with a \$19 barrel from Numrich and a polymer stock from Brownell's.

I ended up needing a Dremel tool to make the action fit in the polymer stock and got a friend to help me drill and tap for scope mounts. When the optics are in place, I will test fire and think about refinishing the barrel.

The little gun is just that, a brush carbine. I used the original walnut and cut it down and added a piece of ebony as a decorative tip. Once all the stock work is done I want to apply a mount for a red dot sight of some sort in front of the action. That way I won't have to cut, weld and reshape the bolt handle like we did with the last one.

As soon as the snow is off the range, I'll get pictures.
